He listened but then the ticket agent called him and he excused himself from our conversation.

I immediately pulled Bruce's business card and asked him for his phone number which he willingly provided. When Bruce arrived, I relayed the wonderful story and after several text messages with the attorney he agreed to meet the next time we were in the city.












## **Airstrip Update**

Please continue to lift Jennilyn up in prayer. We were told she's now pregnant and transferred to the city bakeshop.


